## **Health and Safety**

To ensure the ongoing health and safety of our school community we are required to manage access to the school site, social distancing by adults, frequent handwashing and sanitising, and ensuring that everyone at school is

well. We appreciate your understanding with these measures, such as staggered start and pick-up times, and temperature checks. We will continue to review our processes in light of any changes to Vic. Government COVID-19 restrictions and our school needs. We will update you when changes are made. A COVID-19 Policy was ratified at School Council last night and will be posted on our website.

#### **CCTV**

Our School Council agreed to the installation of CCTV at our school and we are fortunate this has been provided at no cost by the state. This was in response to the high number of thefts, graffiti attacks, break-ins and intruders at our school since we opened. We now have cameras around the perimeter of our school and in the foyer. We are developing a policy to guide access and ensure privacy regarding their use and this will be shared.
